第一條 本校為獎勵品學兼優，並有傑出表現之學生，特訂定本辦法。

第二條 凡本校學生(含研究生)，其前一學期GPA2.93以上，且在學期間無懲處紀錄，並具有下列具體事蹟之一者，經推薦後得為優秀青年之候選人。

- 一、敦品勵學、學術研究表現卓越。
- 二、力行愛國、愛校活動著有貢獻。
- 三、熱心公益、服務社會堪為楷模。
- 四、擔任社團幹部表現優異。
- 五、其他優秀表現足為表率。

第三條 本校各單位、教職員生及學生團體，得於每年公告報名期間內備妥推薦表及相關資料，向承辦單位推薦學生乙名參加候選。  
承辦單位於彙整候選人資料後進行初審，並將初審合格之候選人名冊送交各學院進行複審及排定推薦順序，至多以各學院分配名額乘以2倍(小數第1位採無條件進入)，另不足2名者可至多推薦2名，再送回承辦單位辦理遴選。

第四條 優秀青年遴選評審委員會議，由各學院分別推薦教師乙名組成之。學務長及教務長為評審委員會議之當然委員，學務長為召集人。

第五條 評審委員會議於候選人中遴選優秀青年若干名，頒贈獎牌及證書，並接受本校或校外單位表揚。

第六條 本辦法經行政會議通過後，自發布日施行。

Article 1 National Taiwan University (NTU or “the University”) formulates the NTU *Regulations for Outstanding Youth Selection* (“the Regulations”) to commend students who demonstrate both exemplary character and outstanding academic performance.

Article 2 Any NTU student (including graduate students) whose GPA was 2.93 or above in the previous semester, who has not been issued warnings or demerits during their period of study, and who meets any of the following criteria may, at the recommendation of the competent unit, be nominated as a candidate for the NTU Outstanding Youth Awards:

1. Demonstration of exemplary character, hard work, and exceptional academic/research performance
2. Performing patriotic acts or making extraordinary contributions to the University
3. Dedication to public welfare and social services that sets an example for other youths
4. Excellence service as a student club officer
5. Other notable and praiseworthy deeds

Article 3 Each unit, faculty member, and student group at the University may recommend one student per year by submitting a recommendation form with the required documents to the competent authority during the announced application period.

After all submissions are tabulated, the competent authority shall conduct a preliminary review and compile a list of eligible candidates. The list shall be forwarded to individual colleges, which shall conduct a secondary review to rank the candidates from the most highly recommended to the least recommended. The number of candidates may equal up to 2 times the quota allocated to individual colleges (fractions shall be unconditionally rounded to one decimal place) and up to 2 candidates may be recommended when nominees number less than 2. The results shall be sent back to the competent authority for final selection.

Article 4 An Outstanding Youth Selection Committee (“the Committee”) shall be convened with one faculty member from each college attending. The Vice President for Student Affairs and Vice President for Academic Affairs shall be ex officio members of the committee, with the former serving as convener.

Article 5 The Committee shall select an appropriate number of awardees from among the candidates to be commended and presented with a medal and certificate

by the University or an organization not affiliated with NTU.

Article 6 The Regulations shall be passed by the Administrative Meeting and then implemented on the date of promulgation.
