國立臺灣大學理學院推廣國際交流獎學金設置要點

- 一、目的：為加速邁向頂尖大學之列，培育本院學生國際觀，促進國際學術及文化交流，並鼓勵本院學生出國參與海外教學與研究相關活動，特設置本獎學金。
- 二、經費來源：理學院高等教育深耕計畫經費或自籌收入經費。
- 三、申請資格：凡本院學生因學術提升及教學與研究原因，確有需求者得提出申請。國外交流活動執行期間，必需具有本校學生之在籍身分。
- 四、申請時間：依本院公告辦理。
- 五、審查委員：由本院國際事務委員會成員擔任，副院長兼任召集人。
- 六、核給項目及金額：
 - (一)交換生：交換一學年者(含雙學位)，每名至多補助新台幣20萬元整；交換一學期者，每名至多補助新台幣10萬元整。
 - (二)海外短期研究:包括海外實習、短期研究、暑期班、密集課程等，經系上同意，每名至多補助新台幣6萬元整。
 - (三)其他特殊原因，如發表於國際大型研討會且將會發表於國際知名刊物等，經國際事務委員會審核確認有核准必要者，每名至多補助新台幣4萬元整。
 - (四)以上三項學生核定名額及金額，依該年度經費及學生實際申請狀況調整。
- 七、審查原則：
 - (一)本院國際事務委員會依申請學生之在校成績、家庭狀況及申請締約學校排名高低等審查原則進行甄選。
 - (二)具中低收入戶或低收入戶證明者且通過審查者，優先核發獎學金；其餘名額按甄選名次高低依序核發獎學金。

- (三)海外短期研究不受締約學校、合作學校排名之限制。
- (四)於國際大型研討會發表，依發表形式、發表內容、會議之重要性等原則進行甄選。申請者須同時申請行政院科技部「補助研究生出席國際會議」補助或國外其他獎助，如有特殊原因無法申請者，請另附相關證明文件。惟獲得本項獎學金者，不得同時領取其他補助。
- (五)其餘未盡事宜，由國際事務委員會討論後決議。

八、發放方式

- (一)申請交換一學年者，依接待學校之學制，分二期發給。第二期獎學金需提交前一學期報告，始得發給。
- (二)申請交換一學期者，依交換學期，一次發給當年度二月至六月或當年度九月至次年度一月獎學金。
- (三)申請海外短期研究及其他特殊原因者，於獲知對方學校或機構確認已執行完成後一個月內發放。

九、原則上，院內每位學生一年僅能獲本院補助一次，但有特殊需求者，得於本獎學金年度餘額內，經國際事務委員會審核後，給予補助。

十、獲獎學生中途終止本辦法第六條之各項計畫執行者，則其獎學金之發放亦同時終止。

十一、學生返國後應繳交報告或修業成績相關證明，交由本院國際事務委員會審查。未獲通過本院國際事務委員會審核者，爾後不得再申請本院相關之獎補助。

十二、本辦法經本院院務會議及本校行政會議通過後，自發布日施行。

I. Purpose

In order to advance the role of National Taiwan University's College of Science (hereafter referred to as "the College") as a leading institution, foster a greater international perspective among the College's student body, facilitate international academic exchange, and encourage students and graduates of NTU to engage in international opportunities for research, instruction, and study, the College has established the grant whose guidelines and specifications are described herein (hereafter referred to as "the present grant").

II. Sources of Funding

Dedicated funding under the Higher Education Sprout Project, or the College's net operating income.

III. Eligibility

Any student of the College with financial needs due to the pursuit of higher education and/or research and teaching is eligible to apply for the present grant. In order to be eligible, applying students must remain enrolled at National Taiwan University throughout the duration of overseas student exchange.

IV. Application Timeline

The timeline and relevant regulations for application to the present grant shall be published by the College accordingly.

V. Review Committee

The College's International Affairs Committee shall be responsible for reviewing applicants. Committee members shall be selected by the Associate Dean of the College.

VI. Grant Specifications

- A. Student Exchange: Awardees engaged in one year of student exchange shall each receive up to 200,000TWD in grant funds. Awardees engaged in a single semester of student exchange shall each receive up to 100,000TWD in grant funds.
- B. Short-term Overseas Research: If pursuing overseas internships, short-term research, summer employment, intensive courses, or other initiatives, once approved by the relevant department, each awardee shall receive up to 60,000TWD in grant funds.
- C. Other Special Circumstances: If determined by the College's International Affairs Committee to have met the selection criteria, awardees whose work has been or is expected to be published in an internationally recognized journal or conference shall each receive up to 40,000TWD in grant assistance.
- D. The size and number of grants awarded to students in the three categories above is subject to change in accordance with annual finances and applicant pool size.

VII. Application Review Guidelines

- A. The College's International Affairs Committee shall proceed with awardee selection based on review criteria including the student's academic performance, the student's household status, and the ranking of the partner institution from which the student is applying.
- B. Awardees from low-income backgrounds or who have provided proof of low income shall be prioritized in grant disbursement. Remaining grant funds shall be disbursed based upon applicant rankings.
- C. Funding for short-term overseas research shall not be subject to restraints based upon partner institution ranking.
- D. Applicants belonging to category C of section VI above shall be considered for awardee selection based on the content, quality, and mode of their internationally published work. These applicants must simultaneously apply for MOST Student Researcher International Conference funding or other overseas funding. Special circumstances obstructing application for such other funding must be evidenced by supporting documentation. Awardees shall not receive any other scholarships, grants, or financial assistance while

receiving funding from the present grant.

- E. Any other relevant regulations shall be decided upon following discussion by the College's International Affairs Committee.

VIII. Disbursement

- A. Awardees who have applied for one year of student exchange shall receive funds in accordance with the receiving institution's regulations and in two separate payments. Awardees must submit a first-semester experience report in order to receive the second payment.
 - B. Awardees who have applied for a single semester of student exchange shall receive funds in accordance with the receiving institution's regulations and in a single payment to cover expenses in either February of the award year through June of the award year or September of the award year through January of the next year.
 - C. Awardees who have applied for short-term overseas research (category B of section VI) and awardees applying in consideration of other special circumstances (category C of section VI) shall receive funds within one month of confirmation by the receiving institution or by the relevant journal or conference.

- IX. Each student in the College may obtain funding from the present grant once per year, but students with special needs may receive additional funding following review by the College's International Affairs Committee and while remaining within the annual quota.
 - X. Awardees who discontinue their plans as described in categories A-C of section VI shall likewise have their grant funding discontinued.
 - XI. Upon return to Taiwan, awardees should submit an experience report or documentation showing academic performance to the College's International Affairs Committee for review. Awardees who do not pass this review shall be barred from submitting future applications to the present grant or any related grants and scholarships.
 - XII. The guidelines enclosed herein are in effect per approval by the aforementioned College Affairs Meetings and Administrative Meetings.
